Introduction

On May 25, 2018, a new privacy law called the General Data Protection Regulation (GDPR) takes effect in the European Union (EU). It replaces the Data Protection Directive (Directive”), which has been in effect since 1995. While the GDPR preserves many of the principles established in the Directive, the GDPR gives individuals greater control over their personal data and imposes many new obligations on organizations that collect, handle, or process personal data.

Ex Libris is committed to GDPR compliance across all of our products and services. We have closely analyzed the requirements of the GDPR, and our engineering, product, security and legal teams have been working to align our procedures, documentation, contracts and services to support compliance with the GDPR. We also support our customers with their GDPR compliance journey with our strong foundation of certified security and privacy controls.

This paper describes tools and capabilities built into Leganto that can assist your organization in addressing data subject rights and requests as a *controller* under the GDPR of personal data processed on Leganto.

Definitions

Personal Data means any information relating to an identified or an identifiable natural person (**Data Subject**); an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier or to one or more factors specific to the physical, physiological, genetic, mental, economic, cultural or social identity of that person.

Controller means the natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of personal data. Where the purposes and means of such processing are determined by Union or Member State law, the controller or the specific criteria for its nomination may be provided for by Union or Member State law. With respect to the use of Leganto, the customer is the **controller**.

Processor means a natural or legal person, public authority, agency or other body which processes personal data on behalf of the controller. With respect to the use of Leganto, Ex Libris is the **processor**.

Data Subject is an identified or an identifiable natural person to whom personal data relates (e.g., patrons and staff).

As you read through this paper, keep in mind that your compliance with the GDPR involves your role as the **controller** and Ex Libris as the **processor**.

Summary of Data Subject Rights

The rights of data subjects provided by the GDPR include the following:

1. *Right to be Informed (Article 13, 14 GDPR)*

The right to be informed encompasses your obligation to provide ‘*fair processing information*’, typically through a privacy notice. It emphasizes the need for transparency over how you use personal data.

2. *Right of Access (Article 15 GDPR)*

Under the GDPR, individuals have the right to obtain:

- Confirmation that their data is being processed
- Access to their personal data; and
- Other categories of information - some of which should be provided by the controller in a privacy notice (see Article 15).

3. *Right to Rectification (Article 16 GDPR)*

Individuals are entitled to have their personal data rectified if it is inaccurate or incomplete without undue delay. If you have disclosed the personal data in question to third parties, you must inform such third parties of the rectification unless this proves impossible or involves disproportionate effort. You must also inform the individuals about the third parties to whom the data has been disclosed where requested.

4. *Right to Erasure (Article 17 GDPR)*

This right is also known as the *Right to be Forgotten*. It enables an individual to request the deletion or removal of personal data where there is no compelling reason for its continued processing.

Individuals have the right to have their personal data erased and to prevent further processing of their personal data in specific circumstances delineated in the GDPR, such as:

- Where the personal data is no longer necessary in relation to the purpose for which it was originally collected/processed.
- When the processing was based on consent, and the individual has now withdrawn their consent.
- When the individual objects to processing and there are no overriding legitimate grounds for continuing the processing.
- The personal data was unlawfully processed.
- The personal data has to be erased in order to comply with a legal obligation in Union or Member State law to which the controller is subject.

There are circumstances described in the GDPR where the right to erasure may not apply and a controller can resist a request for erasure.

5. *Right to Restrict Processing (Article 18 GDPR)*

When this right is exercised you are permitted to store the personal data but not further process it. The *Right to Restrict Processing* applies in the specific circumstances set forth in the GDPR, including:

- Where an individual contests the accuracy of the personal data, then processing should be restricted for a period enabling the controller to verify the accuracy of the personal data.
- When processing is unlawful and the individual opposes erasure and requests restriction instead.
- If you no longer need the personal data but are required by the individual to establish, exercise or defend a legal claim.
- Where an individual has objected to processing for reasons specified in the GDPR, pending the verification whether the legitimate grounds of the controller override those of the individual.

6. *Right to Data Portability (Article 20 GDPR)*

This right allows individuals to receive the personal data the individual provided to a controller in a structured, commonly used and machine-readable format and to transmit such data to another controller, without hindrance from the original controller. In exercising this right, the individual shall have the right to have the personal data transmitted directly from one controller to another, where technically feasible.

The *Right to Data Portability* applies where the individual has given consent to the processing of their personal data for one or more specific purposes, or where processing is carried out by automated means or in other circumstances specified in the GDPR.

7. *Right to Object (Article 21 GDPR)*

Individuals have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data which is based on certain specified provisions of the GDPR, including profiling based on those provisions.

8. *Right Related to Automated Decision Making and Profiling (Article 22 GDPR)*

The GDPR provides safeguards for individuals against the risk that a potentially damaging decision is taken without human intervention.

Individuals have the right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning the individual or similarly significantly affects the individual. The GDPR provides certain exceptions and conditions to this right.

9. *Right Related to Data Breach Notification (Article 34 GDPR)*

The GDPR introduces a duty on controllers to report certain types of data breaches to the relevant supervisory authority, and in some cases to the individuals affected by the breach.

A personal data breach is a breach of security leading to the accidental or unlawful destruction, loss, alteration, unauthorized disclosure of, or access to, personal data transmitted, stored or otherwise processed. Where a breach is likely to result in a high

risk to the rights and freedoms of natural persons, the controller is required to communicate the personal data breach to the data subjects without undue delay.

Addressing GDPR Data Subject Rights with Leganto

The following section describes the capabilities of Leganto that can assist customers in complying with the rights of data subjects. The information is provided for Patrons (students and instructors) as the Data Subject and for Staff users as the Data Subject.

1. Rights of Data Subjects – Patrons – Students

Right to Erasure (Right to be Forgotten)	The user profile containing basic information about the user such as email and address is managed in Alma and can be edited or deleted. For Student Success Measurements, information on deleting individual student usage data can be found here . See Data Fields Used in Leganto for detailed information about data in Leganto.
Right to Restrict Processing	The user profile containing basic information about the user such as email and address is managed in Alma and can be edited or deleted.

1. Reading Lists

Field	Description
Instructors and Collaborators IDs	The IDs of the instructors and collaborators
Reading List Creator	The creator of the reading list
Reading List Modified By	The person who modified the reading list
Reading List Owner	The owner of the reading list
Reading List Score	The score of the reading list

2. Citations

Field	Description
Citation Creator	The creator of the citation
Citation ID	Citation ID

3. Student Usage

Field	Description
Students Discussion	Discussion comments between the instructor and the student for a citation or a list
My collection	A set of the citations the student has selected and saved as a private collection

4. Instructor Usage

Field	Description
Students Discussion	Discussion comments between the instructor and students for a citation or a list
My collection	A set of the citations the user has picked and saved as a private collection
My reading lists	All reading lists that the instructor created or edited, alone or together with others
Usage Event	Every event performed by the instructor is logged, including instructor, date, type of event (e.g., Add Citation Public Note), event value (e.g., the specific note added), and date
Library Discussion	Discussion comments between the library and the instructor for a citation or a list

5. Student Success Measurement Feature - Optional

This information is available **only** if the customer has opted into and activated the Student Success Measurement feature. As with storage and processing of all personal data, we remind customers that they must have a legal basis for processing this additional personal data and, if required, informing its data subjects.

Field	Description
Activity: List Viewed	Kept for each student's view of a list
Activity: Citation viewed	Kept for each view of a student's citation
Activity: Link click	Kept, per citation, for each click on a link
Activity: File download	Kept, per citation, for each file download
Activity: Like	Kept, per citation, for each time a user clicks Like
Activity: Comment	Kept per comment (on a citation and on list)
Activity: Done	Kept per citation for each time a user clicks Done
Attribute: Mobile Activity	Kept per any of the activities above, if the student was using a mobile device.

Field	Description
Attribute: Non-Mobile Activity	Kept per any of the activities above, if the student was using a non-mobile device.
Attribute: Events using LTI	Kept per any of the activities above, if the student accessed Leganto from the learning management system by clicking a Learning Tools Interoperability (LTI) link.
Attribute: Operating System	The operating system of the student's device, kept per any of the activities above.
Attribute: Browser Type	The browser type of the student's device, , kept per any of the activities above.
Attribute: Browser Version	The browser version of the student's device, kept per any of the activities above.
Attribute: LTI Profile Code	The LTI profile code, kept per any of the activities above (when an LTI link was used to access Leganto).
Attribute: Citation Library Internal Tags	The library internal tags of the citation, kept per citation, per any of the activities above.
Attribute: Student Type	The student type, kept per any of the activities above.
